When can we use Certifydoc?

- Appraisal and valuation

Appraisal of property and real estate rights report of any kind.

- Maintenance, construction progress and renovations

Before or after repairs or routine maintenance, giving dated legal relevance to performance management documents and video-photographic inventory of the condition of sites or objects can prevent unnecessary conflicts and free up time and productive resources.

Before, during and after the construction or renovation of any property, it is important to create a photographic or video inventory to verify the state of the constructions, tools, materials, etc.

You can also prove that you are not responsible for infiltrations, cracks and other damage, or that they already existed.

- Entering and leaving a rental property

Before and after renting a flat or office, it is important to create a videophotographic inventory to verify the condition of the property. It protects the landlord when entering and the tenant when leaving. It avoids conflicts with the return of the deposit, something that happens more often than expected.

Furthermore, it is also very useful with seasonal and tourist leases, due to the high frequency of tenant arrivals and departures.

- Sales and purchases

In remotely promoting and selling to international clients who do not visit the property beforehand. Certified photos and videos can convince a customer to buy from a highly trusted certified service provider.

Sale of commercial or industrial real estate.

Judicial or voluntary auctions. Exchange of all kinds of real estate.

- Managements

Use it to certify all administrative documentation related to homeowners' associations: accounting, communications, current accounts, employees, personal data, quotas, debts, suppliers, insurance and claims follow-up, also use the certification as a deterrent to avoid conflict for clients who try to breach the agreements.

Use it to give legal relevance to all kinds of procedures before any state, autonomous, provincial or municipal organization.

Government agencies are obliged to comply with regulations and give value to accredited evidence from government authorities, such as those provided by Certifydoc through the accredited service providers of the local state and the EU.

- Lowering a property tax assessment by the Tax authority when buying in need of renovation

In the event that the Tax Agency (TA) detects that the declared amount of the purchase is less than the supposed value of the property, according to the TA's own records, the TA can claim at least the difference in tax that is considered not yet settled for the difference in price.

It is at this point when we understand the usefulness of being able to produce certified photos and videos with legal relevance, in order to demonstrate to the TA that the lower price at the time of acquisition was due to the poor condition of the property.

With the certifications, we will be able to respond with an appeal for reconsideration or an economic-administrative appeal.

- Mass emailing with certified acknowledgment of delivery

In calls for meetings and follow-up with defaulters. In a few well-regulated and controlled steps our experts will perform the mass mailing and provide you with everything you need to detail the mailings, their results, statistics and how to keep them for legal use.

- Avoid problems and lawsuits

Legal

According to current law, photos, videos and electronic documents have very low legal relevance because their content and date can be easily manipulated. So how can I protect myself to prove the status of a property at a given time?

Without Certifydoc the documentary evidence is uncertain.

- Do my documents have sufficient probative value?
- Can they be challenged?
- Have they been manipulated?
- Can I prove that they have been created on a specific date?

With Certifydoc the answer to these questions will always be favorable to your interests, which will be very useful when negotiating with buyers, authorities, clients, tenants, owners, experts, lawyers, both in the previous negotiations and before or after a lawsuit. Having evidence with the maximum legal value (probative value) can avoid lawsuits and long conflicts that nobody wants to suffer.
